

### We understand and build on the strengths and needs of young people

Many of the young people we work with have never been asked what they want to do for a living or what their dreams for the future are. At UK Youth we believe everyone has potential and our role is to enable them to unlock it so they can flourish. Listening to young people is at the heart of this process and their voice informs everything we do.

#### We offer support and advice to youth service providers

We sit at the heart of a national movement of Changemakers and Innovators, brought together to support one and a half million young people across the UK. The movement unites national, regional and local youth organisations behind a common purpose – to ensure access to appropriate, high quality services for all young people in every community.

#### We run world class skills development programmes for young people

Together with the organisations in our movement, we offer support, advice and training to equip young people with the vital life skills needed to engage in education, volunteering and employment. Our life skills programmes are supported by a range of trusts, foundations and businesses, including PwC, Microsoft, Spirit of 2012, UPS, National Lottery Community Fund, Oliver Bonas, LinkedIn and more. We deliver life skills training in youth organisations all across the UK and through outdoor leaning in the New Forest at our dedicated centre, Avon Tyrrell.

#### We measure impact and share learnings

As a learning organisation we are constantly adapting and improving how we operate to ensure the work we do with young people is as effective as possible. We are keen to share our learnings widely to maximise the social impact of the whole youth sector. This is achieved primarily by sharing written insights, hosting seminars, speaking at conferences, and meeting with delivery organisations and decision makers.

### We influence policy and funding to prioritise services for young people

UK Youth have been instrumental in unlocking funding for the sector; raising over £20million from businesses, trusts and foundations for the youth sector, working with DCMS on the creation of the £40million Youth Investment Fund and £90million Youth Futures Foundation, and influencing the approach taken by the Home Office with the £200million Youth Endowment Fund.

We worked together with The Scouts, Girlguiding, National Youth Agency, NCS Trust, Youth United Foundation, Step Up To Serve, The Prince's Trust, and the British Youth Council to call on Government to commit to developing a Youth Charter.

### Our reach

The work of UK Youth has never been more important given the challenges, issues and barriers so many young people face. Our focus is on those young people who face barriers to progression. The most common personal barriers reported by young people in our network are:



Area of deprivation



Not in education, employment or training (NEET)



Low income family



Low educational attainment



Rural isolation

of our young people on our programme report at least one personal barrier



We want to identify and connect up good practice and learnings from youth organisations across the UK, to act as a catalyst for the creation and delivery of world class youth services for young people. UK Youth is committed to standing with young people, youth workers and volunteers to ensure their voices are heard and their knowledge is shared.


Together, we can ensure the young people who need it most have access to high quality services in their local area.

### **Finances**

#### Income

In 2018/19 we raised £6.1 million towards our mission of providing access to appropriate, high quality services for young people across the UK. Our funders include trusts, foundations, corporates, government and individuals.



Of the total income of £6.1 million, £3.8 million was received as restricted income (money given for a specific purpose).

### Role profile

#### **Purpose**

- To provide strategic leadership to UK Youth in collaboration with the Chief Executive and the Board of Trustees.
- To inspire the Board, Chief Executive and those within and outside of UK Youth through the promotion of the organisation's vision, mission and values.
- To oversee development and delivery of the charitable aims through the strategic plan, as agreed by the Board.
- Ensure that the charity is compliant with all legal, financial, reporting and other requirements.

Approximately two days a month

**Board Meetings:** 

Four Board Meetings per annum with one annual residential away day at UK Youth's centre, Avon Tyrell

#### **Remuneration:**

This role is unremunerated. Travel expenses as well as other out of pocket expenses directly incurred, as part of official Trustee business will be reimbursed.

#### Key responsibilities

- To undertake the duties of a Board member.
- To Chair the Board in particular by:
  - Giving direction to policy and strategic decision making;
  - Ensuring that the Board makes clear decisions on strategy, policy, financial stewardship and risk exposure;
  - Monitoring the implementation of the Board decisions;
  - Planning the annual cycle of meetings with the Chief Executive.
- To monitor the performance of the Board, its members, and the Chief Executive.
- To develop the Board and to ensure that members are properly inducted and supported.
- To update and monitor the code of conduct for Board members and the scheme of delegation for the Chief Executive.
- On behalf of the Board to supervise and appraise the Chief Executive and delegate to the Chief Executive the management of the organisation.
- To represent the organisation when appropriate.

# Person specification

- A commitment to the mission, aims and ethos of UK Youth.
- An understanding and awareness of the role of the youth sector and challenges that young people are facing, particularly those from disadvantaged communities, and an ability to relate effectively to the young people whom UK Youth works with.
- A good understanding of the social, economic and political context in which UK Youth works and a willingness to further develop this understanding.
- Ability to chair effectively a diverse Board of Trustees in governing an organisation and demonstrating a commitment to the importance of diversity as part of good governance.
- Understanding of and ability to promote effective governance practices in the context of a registered charity.
- A willingness to engage on behalf of the charity with a network of personal and professional contacts that would support fundraising, advocacy and influencing for the benefit of UK Youth and the work we do for young people.
- Highly credible, a natural communicator and 'people person'.
   Able to inspire audiences (staff, supporters etc.) with clear and compelling messages about UK Youth.

- The ability and willingness to represent the charity and to play an ambassadorial role with policy makers, supporters and others.
- The confidence and ability to provide support to Trustees and to evaluate the performance of the Board.
- The ability to provide supervision and guidance to the Chief Executive and to work collaboratively in developing and implementing the strategy and monitoring performance of the organisation.
- Independence of thought and judgement with a willingness to accept and promote collective responsibility for decisions reached by the Board collegiately and democratically.
- Time and enthusiasm to dedicate to the role of Chair. The commitment to prepare for and attend four full Board meetings each year and Board sub-committee meetings as appropriate; to represent the organisation regularly; and to interact with the Chief Executive for supervisory meetings on a regular basis and in between as required and to conduct annual performance reviews for the CEO and Trustees.
- A willingness to travel to represent UK Youth.


