
Context	The University of Lincoln Students' Union (ULSU) is a Charity which exists to support students in both their academic and non-academic experiences, whilst working closely with the University and local community. It has four trading subsidiaries which supports the activities of the Students' Union financially.
	The Board of Trustees is the governing body of the Students' Union and is chaired by the Honorary President of the Students' Union. The Board currently comprises of Sabbatical Trustees (inclusive of Chair), External Trustees with differing skills and expertise, a Senior Member of University staff as nominated by the Vice Chancellor and three Student Trustees.
	<b>The Board of Trustees convenes a minimum of five times a year,</b> as well as a series of sub-committees of the Board of which Trustees are appointed to dependent on relevant skills and expertise.
Job Purpose	The Trustees are collectively responsible for ensuring that the University of Lincoln Students' Union is run effectively, compliant with Charity Commission and other relevant legislation, financially secure and sets the strategic direction of the organisation. The Chief Executive, line managed by the Board of Trustees, has delegated authority to manage the day to day operations of the Students' Union with oversight from the Trustees.

Candidate Specification	<ul> <li>The applicants for this role will have specific, relevant experience within the Finance sector. This could include, but is not limited to, a professional background in an accountancy firm or an associated specialism.</li> <li>We welcome applications from candidates from a variety of backgrounds.</li> <li>Whilst it is not a pre-requisite, the ideal candidate would reside within Lincolnshire. However, candidates residing outside of the county may be considered subject to their ability to offer the necessary time commitment to the role and their support of the Chief Executive.</li> <li>The applicants for this voluntary role will be interviewed by the Appointments Panel and approved by the Board at the next scheduled meeting.</li> </ul>
Time Commitment	At the time of writing, the Finance & Risk Sub-Committee meets monthly considering the impact of Covid-19 on ULSU's operations. The full Board of Trustees meet five times per year, with the caveat that Extraordinary meetings may be called as necessary for urgent items requiring the Board's attention. All pre-arranged meetings are scheduled during business hours, although Extraordinary meetings may occur during the evening. Where possible it is preferable for the full Board to meet in person, although dial in facilities are available. Sub-Committee meetings normally occur virtually. In addition to the above, there is a summer residential event (encompassing two days and an overnight stay) for the Board in August of each year.

#### The closing date for applications is 5pm on 9th February 2021.

We will be holding interviews on the afternoon of 2nd February 2021, and we will be in touch with all applicants to let you know if you are shortlisted for an interview.

These interviews will be with the Chief Executive, the Chair and two other Trustees and will be an opportunity for them to get to know you and for you to find out more about the role.

The successful candidate will be asked to attend an induction meeting with the Chief Executive, where they will be able to find out more about the organisation as well as completing the relevant paperwork.
