WHO WE ARE

Hampshire and Isle of Wight Community Foundation (HIWCF) is an independent charitable foundation and the largest grant maker to specialise in awarding grants across Hampshire, the Isle of Wight, Portsmouth and Southampton to smaller, less well-known charities, community groups and voluntary organisations.

We have built endowment funds of over £15m for the long term benefit of our communities and in the last 10 years we have distributed over £10m in grants to support over 3,000 community projects across Hampshire and the Isle of Wight. We are proud to have reached out to nearly 500,000 people living in our local communities.

Working with our partners, the Foundation is well placed to address the challenges presented by the Covid-19 crisis, which has caused enormous hardship in our communities, damaging the health, wellbeing and livelihoods of local people. In response, HIWCF established a 'We're All Together' campaign, which began raising funds in March 2020, to provide emergency grants to those resourceful local charities and community groups that either sprang up to help vulnerable local people affected by the lockdown, or extended their existing services to help those in need. Due to the amazing generosity of our donors, the National Emergency Trust and others, so far we have raised in excess of £2.2 million to help support those crucial groups and services who on a daily basis are working tirelessly to meet the needs of those in our communities.

About Hampshire and the Isle of Wight

In Hampshire and the Isle of Wight the effects of poverty and deprivation are not at first glance obvious, as our location in the affluent South East is, after all, home to Hart, which is classified as the least deprived district in the country. However, Government statistics show that in other areas local deprivation is on a par with the highest levels in England.

The 2019 Indices of Deprivation show that across Hampshire and the Isle of Wight, 44 neighbourhoods fell into the 10% most deprived areas in England, and a further 81 areas fell into the next 11-20%. The two cities of Southampton and Portsmouth contain some of the highest levels of deprivation, and overall a further 11 areas in the region have been recognised as deprived since 2015.

About Community Foundations

The 46 UK Community Foundations are a movement of county-based philanthropic Foundations committed to positive social change through community philanthropy. They are usually the largest or only county-based charity, and involve people from all parts of the community working together to harness local financial and other available resources to improve local people's lives. HIWCF is part of the UK Community Foundation network and the CEO benefits from UKCF representation and support, as well as from strong peer relationships.

FINANCES

Hampshire & Isle of Wight Community Foundation (HIWCF) holds total charitable funds of over £15.5m. The funds comprise:

- endowment funds which are invested to generate investment returns for grant making (c. £14m)
- restricted funds (£1.2m) that are in the process of being used for grant making
- unrestricted reserves (c. £377k) which are held as a contingency to cover core costs (c. £350k p.a.) and to underwrite investment in development opportunities.

2020 has been an exceptional year responding to the coronavirus pandemic. In 2020, we launched an emergency 'We Are All Together' appeal. By the end of the year, we had raised £2.2m and distributed grants for Covid relief totalling £1.75m to over 400 community groups and charities and reaching over 350,000 people. The remaining funds are scheduled for distribution in 2021.

We also secured funding from the European Social Fund and our local authorities for the Solent Supporting Employment Grants Programme. This programme (worth £1.76m over the period to March 2023) commenced in 2020 to support people, with complex barriers to work, move towards or into employment.

In addition, we attracted capital income for two new endowment funds worth c. £1.5m, have managed our ongoing grant programmes, and are continuously seeking new funding sources to add new areas of interest to our donors.

- Make our communities a better place by increasing philanthropic behaviour and managing our assets efficiently
- Improve our communications so that communities, partners and donors recognize HIWCF as the key grant making and fundraising charity locally
- Target grant making at communities most in need
- Establish HIWCF as the first choice for grant giving, known for its collaborative approach and knowledge of local community needs.

Strategy and the future

ROLE DESCRIPTION: TREASURER

The overall role of a treasurer is to maintain an overview of HIWCF's financial affairs, ensuring its financial viability and ensuring that proper financial records and procedures are maintained.

Key responsibilities:

- Overseeing and presenting budgets, management accounts and financial statements.
- Being assured that the financial resources of HIWCF meet its present and future needs.
- Presentation of Treasurer's written and financial reports to the Board of Trustees.
- Ensuring that appropriate accounting procedures and controls are in place.
- Liaising with paid staff and volunteers about financial matters.
- Advising on the financial implications of HIWCF's strategic plans.
- Ensuring that the accounts are prepared and disclosed in the form required by the Charity Commission and the Registrar of Companies.
- Keeping the Board of Trustees informed about its financial duties and responsibilities.
- Making a formal presentation of the accounts at the Annual General Meeting and drawing attention to important points in a coherent and easy to understand way.
- Providing support to the Finance Manager on technical aspects of the role.
- Chairing the Finance & Investment Sub-committee.
- Oversight of the investment strategy investment advisors and auditors.

Person Specification:

In addition to the qualities needed by all trustees, the Treasurer should also possess the following:

- Relevant qualifications and experience e.g. qualified Accountant.
- A willingness to be available to staff for advice and enquiries on an ad hoc basis.
- The skills to analyse proposals and examine their financial consequences.
